

# VOLUNTARY DECLARATION OF OCCUPANCY AS AN EXERCISE OF AN ABORIGINAL OR TREATY RIGHT

## PURPOSE OF THIS FORM

The Department of Lands is providing an opportunity for cabin owners to voluntarily declare that their untenured occupancy is ancillary to the exercise of an established or asserted Aboriginal or Treaty right and, as such, their untenured structure(s) should be considered a 'potential rights-based cabin(s)'. **Cabins confirmed to be a potential rights-based cabins will not be subject to further enforcement action at this time.**

All untenured occupancies, including potential rights based cabins, are being evaluated on a case-by-case basis, and some may be eligible for a standard GNWT cabin lease. If your cabin is not confirmed as a potential rights-based cabin, and tenure, such as a lease, is not in place, you may be subject to standard trespass proceedings as an unauthorized occupant.

## INSTRUCTIONS

Completion of this form is voluntary. There are two options for completing this document in order to identify your occupancy as a potential rights-based cabin:

**OPTION 1:** You can complete the document and return it directly to the Department of Lands (Lands). Lands will then contact the Indigenous Government or Organization you have identified to complete section D which confirms the information provided.

**OPTION 2:** You can complete the document and return it to your Indigenous Government or Organization. They will then complete section D, which confirms the information in the form, and forward the document to the Department of Lands.

# VOLUNTARY DECLARATION OF OCCUPANCY AS AN EXERCISE OF AN ABORIGINAL OR TREATY RIGHT

The GNWT Department of Lands is requesting confirmation of your asserted or established Aboriginal and Treaty rights, in order to confirm that your cabin is a potential rights-based cabin. This allows the Department to distinguish potential rights-based cabins from unauthorized occupants and support land management with respect to this occupancy of public land. The personal information you provide in this document is being collected under the authority of section 40(c)(ii) of the *Access to Information and Protection of Privacy Act (ATIPPA)*. Your personal information is also subject to the protection and disclosure provisions of ATIPPA, and may be used or disclosed in accordance with the provisions of that Act. **Access to Information and Protection of Privacy Act**

40. No personal information may be collected by or for a public body unless

- (a) the collection of the information is expressly authorized by an enactment;
- (b) the information is collected for the purposes of law enforcement; or
- (c) the information relates directly to and is necessary for
  - (i) an existing program or activity of the public body, or
  - (ii) a proposed program or activity where collection of the information has been authorized by the head with the approval of the Executive Council.

41. (1) A public body must, where reasonably possible, collect personal information directly from the individual the information relates to unless

(a) another method of collection is authorized by that individual or by an enactment;

(2) A public body that collects personal information directly from the individual the information is about shall inform the individual of

- (a) the purpose for which the information is collected,
- (b) the specific legal authority for the collection, and
- (c) the title, business address and business telephone number of an officer or employee of the public body who can answer questions about the collection, unless the regulations provide that this subsection does not apply to that type of information.

42. The head of a public body shall protect personal information by making reasonable security arrangements against such risks as unauthorized access, collection, use, disclosure or disposal.

43. A public body may use personal information only

(...)

(b) if the individual the information is about has identified the information and consented, in the prescribed manner, to the use;

(...)

48. A public body may disclose personal information

(...)

(b) where the individual the information relates to has identified the information and consented, in the prescribed manner, to its disclosure;

(...)

**Access to Information and Protection of Privacy Regulations**

5. The consent of an individual to a public body's use or disclosure of his or her personal information under paragraphs 23(4)(a), 43(b) and 48(b) of the Act

- (a) must be in writing; and
- (b) must specify to whom the personal information may be disclosed or how the personal information may be used.
